Ultimate DrupalCon Experience Sweepstakes Official Rules No Purchase Necessary to Enter

1. **Sweepstakes Period:** The **Ultimate DrupalCon Experience** Sweepstakes (the "Sweepstakes") starts at 12:00 UTC-5 on March 13, 2017 and ends at 11:59 UTC-5 on March 22, 2017 ("Sweepstakes Period").

2. **Eligibility:** Only first time attendees of DrupalCon are eligible, any previous guests are not eligible to enter and cannot be awarded the Sweepstakes. Employees of DrupalCon, Inc. - dba The Drupal Association (the "Sponsor") and each of their respective parent companies, affiliates, subsidiaries, retailers, advertising and promotion agencies as well as their immediate family members (spouses, parents, children, siblings, and their spouses) and/or persons living under the same household are not eligible to enter. This Sweepstakes shall be construed and evaluated solely according to United States law and subject to all federal, state and local laws and regulations. Void where prohibited. By entering, entrants acknowledge compliance with these Official Rules, including eligibility requirements.

3. How to Enter: During the Sweepstakes Period there is one method of entry. All entries become the property of the Sponsor, and will not be returned or acknowledged. Sponsor is not responsible for postage due mail, lost, late, damaged, misdirected, illegible, incomplete, stolen or fraudulent entries. Sponsor does not assume responsibility for third parties' failure to act in accordance with Sponsor's instructions pertaining to the implementation of the Sweepstakes. Sponsor and its agencies are not responsible for lost, interrupted, or unavailable network, server, or other connections; or miscommunications, computer or software malfunctions, telephone transmission problems, technical failures, garbled transmissions, damage to a user's computer equipment (software or hardware), or other errors or malfunctions of any kind whether, human, mechanical, electronic or otherwise. disqualify the entry. Sponsor has the sole discretion to determine whether an entry is eligible. Any entry that violates this section or is otherwise objectionable (as determined solely by Sponsor), will not be considered and will be disqualified.

5. Prize: The winner will receive one DrupalCon full-week ticket (valued at \$550). The winner will also receive one local hotel room the Sponsor's' choice. The hotel room will be available for check-in on Monday, April 24, 2017 and check-out on Saturday, April 29, 2017 (valued up to \$1,070). Additionally, the winner will receive a round trip economy airfare on the most affordable yet convenient flight to/from Baltimore Washington International Airport. Airplane ticket will not exceed \$650 including taxes. Lastly, the winner will have a thirty minute one-on-one meeting with Dries Buytaert (value is priceless!). The winner will be notified via email within 5 days of the drawing and will be required to complete and return a Declaration of Eligibility/Liability and Publicity Release ("Release") which must be returned for receipt within 10 days of date printed on notification or s/he will be disgualified and an alternate potential winner will be selected in a random drawing. If notification email is returned as undeliverable (sent 3 times over a 7 day period), the Release is not returned on time it will result in disgualification, and the prize will be awarded to an alternate winner in a random drawing.
